WELCOME FROM EXECUTIVE DIRECTOR

_____ We believe the Bible to be the inspired and only infallible authoritative Word of God.
(II Tim 3:16)

_____ We believe that there is one God, co-equal and co-eternal in three persons: Father, Son and Holy Spirit. (Matt 3:16,17; 28:19,20)

_____ We believe in the deity of our Lord Jesus Christ, in His virgin birth, in His sinless life, in His miracles, in His substitutionary and atoning death through His shed blood, in His resurrection, in His ascension to the right hand of the Father, and in His personal return in power and glory. (I Cor. 15:3, 4; Acts 1:11; I Peter 2:21, 24; John 3:16)

_____ We believe that for salvation of lost and sinful man, regeneration by the Holy Spirit is absolutely essential. (Rom. 3:21-30; Gal. 4: 4-7)
